Sign Permit Submittal Requirements

Applications will not be accepted without all of the required supporting documents. Please check that each of the following items are submitted with your application:

- Wall Signs: To scale drawing of wall sign located on building elevation with length and height of wall dimensions shown
- Freestanding Signs: Site plan with north arrow and scale showing property lines, existing and proposed sign locations
- Dimensioned diagram of sign copy and structure, showing color, materials, total square footage, and type of illumination
- Landlord approval (if in a multi-tenant building) on drawings
- Sign Permit Application for each sign and applicable fee

Sign Size Standards

CONSTRUCTION STANDARDS

- Wall signs shall be constructed as individual raised mounted letters a minimum of one inch (1") in depth
- Within the B-2 Neighborhood Business District, freestanding signs shall be limited to monument signs not to exceed six feet (6') in height.
- Monument signs up to six feet (6') in height shall be located no closer than five feet (5') from a street right-of-way; Freestanding signs over six feet (6') in height shall be located no closer than twenty feet (20') from the front street right-of-way
- Illumination In B-1 And B-2: Signs in all B-1 and B-2 Districts may only be illuminated during business hours, or until eleven o'clock (11:00) P.M., whichever is later.
- An electrical permit is required for each installation, alteration or addition of electrical work for light, heat and power on signs above or below ground.
- A building permit is required for any new sign or footing construction over 7' in height.
