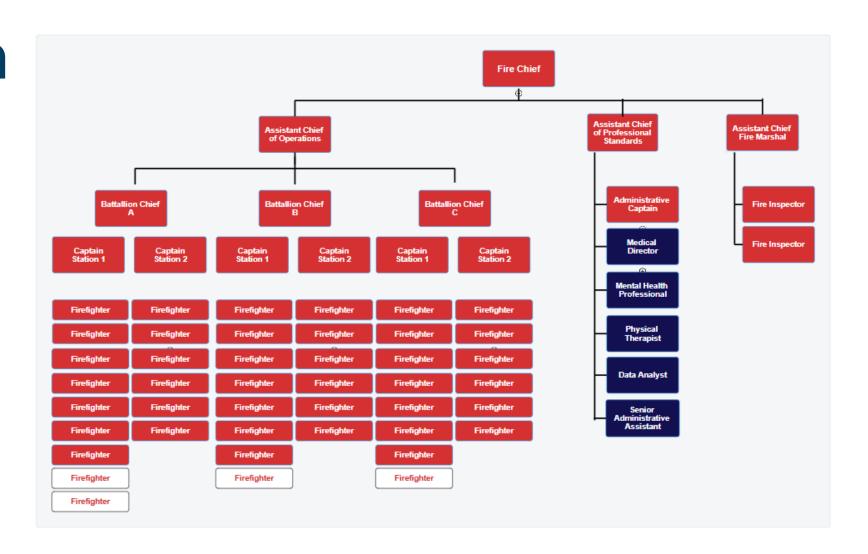

Major changes in revenues

- Increase of EMS demand does not match revenues (revenue per call continues to decrease)
- For opioid funding, some paid more of the settlement up front, others will pay over numerous years
- Permits, inspections, and false alarm fees stay relatively consistent

- Majority of expense is personnel
- Increasing staffing levels in accordance with organizational analysis and standards of coverage to meet growing demand for service

- Cost of equipment and apparatus continue to increase with lead times being multiple years
- Vehicle maintenance has been outsourced for larger apparatus and increase our preventative maintenance

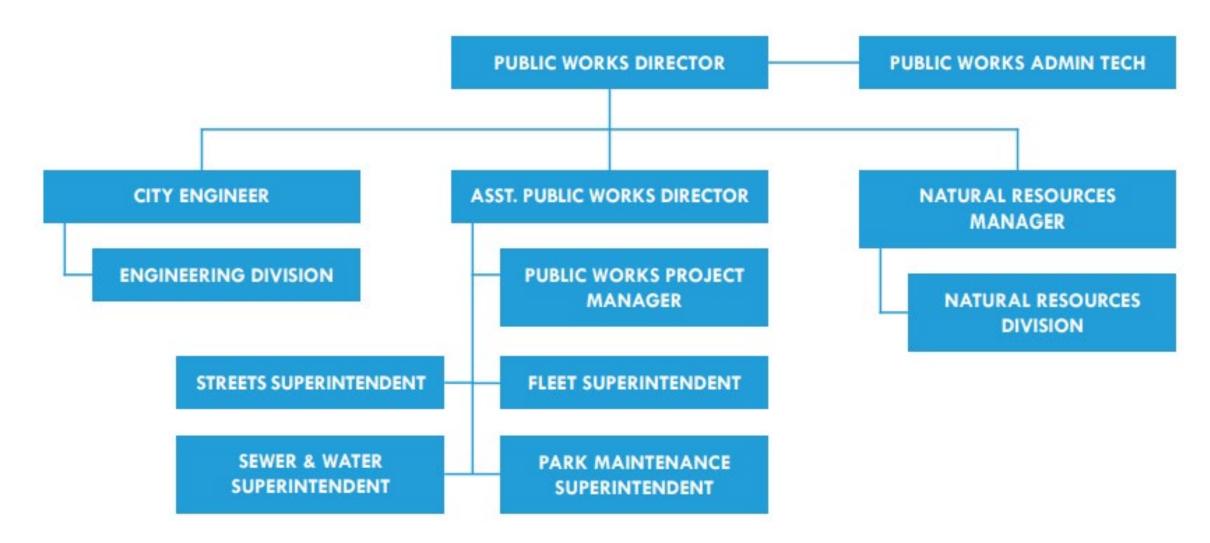
